## III. Applying for a Reduced Amount

Project applicants may choose to apply for less than the maximum amount available. This is sometimes referred to as a "partial reallocation."

Under a partial reallocation, excess funds will be added to the General Funding Pool.

Projects will not be able to claim bonus points toward a new project in response to a partial reallocation. (For more information, refer to the New Project Scoring Tool, Scoring Element b., "Reallocation.")

Project applicants that are considering reapplying for less than the maximum amount available are strongly encouraged to consult with CoC staff before submitting their renewal application for consideration.

### IV. Not Applying

Project applicants may choose not to apply for renewal funding. This is sometimes referred to as "voluntary reallocation."

Under a voluntary reallocation, all funds will be added to the General Funding Pool.

Projects may claim bonus points toward a new project in response to a voluntary reallocation. (For more information, refer to the New Project Scoring Tool, Scoring Element b., "Reallocation.")
